Implemented in 2018, the UAE's VAT system imposes a 5% levy on taxable goods and services, with exemptions for key sectors like healthcare and education. Administered by the Federal Tax Authority (FTA), it mandates registration for businesses exceeding AED 375,000 in taxable supplies. Compliance requires accurate invoicing, timely filings, and proper documentation to avoid penalties.

Excise Tax Services

The UAE introduced Excise Tax under Federal Law No. (7) of 2017 on Excise Tax, which was announced in early 2017. The law was implemented on October 1, 2017, targeting specific goods deemed harmful to human health or the environment. This indirect tax applies to tobacco products, energy drinks, and carbonated beverages at high rates of 50% or 100%. The policy aims to reduce consumption while generating government revenue for public services.
